The Klamath River By Jim Bowen

We arrived at the Klamath River Inn on Monday 10/1. Very cool old-school motel. It was dated, but the rooms were fine. There were microwaves and small refrigerators with a large community patio with two gas grills.

I rigged up and fished the run in front of the motel that evening and landed one decent 1/2-pounder and had a couple more grabs. Next morning I was up early and swung the motel run again and landed this nicer steelie. We fished the next two days from east of Happy Camp down to nearly Orleans. Vivian swung flies on a traditional fly rod while I swung a two-hander. We caught trout and 1/2-pounders, or at least had grabs at every access we fished.

There are tons of accessible water for the drive and hike angler., including quite a few marked access points with chem toilets and parking and roadside pullouts that overlook some nice looking runs. Anyone that would like to chat about it can see me at the meeting this week.

Conservation Notes

Our Water Plan Déjà vu All Over Again

This may sound like "déjà vu all over again", but the California State Water Resources Control Board has once again delayed their decision on the "Delta/River Water Quality Plan"! This time, at the last minute, Governor Brown and Governor Elect Newsom requested a delay until December 12 to allow more time for "negotiated settlements..."

The plan as it stands appears to be fiercely opposed by the "Irrigation Districts" and other profit centric businesses, some elected officials (from locals officials on up), and the Feds. Most of the opposition seems to be from high-level officials, those that don't seem understand or care about the health and welfare of wildlife, the environment, climate change, and even the short-term health/survival of the human population.

Why do others want to deny the use of water for the citizens of this area (fish, recreation, all wildlife of the area)? Profit, pure, simple, and obvious. Many want the population, along with land and water use, to grow (immensely) in the state, county, and city areas to provide more customers for water and electricity; sales of land for houses and new businesses; the creation of increased profits for private companies, agribusiness/corporate farms; and much increased taxes for the government coffers.

A week ago, the Water Board seemed poised to approve the plan. However, the Board is under incredible pressure from all levels, and all directions. What are we to do? Since the delay does at least, allow us to get in one last(?) chance to get someone at the "Water Board" to listen to you. We should use this opportunity. It is time to send another letter to the State Water Resources Control Board. Below is a draft, to use or not. Please feel free to use your own words, concerns, poetry or prose!

Subject: Comment Letter - San Francisco Bay Delta Water Quality Control Plan

California's water is a public trust resource. This is as it should be. The Clear inherent rights and codified legal meaning of this concept is that the majority of water, and the "earth" surface on which the water lies, belongs inherently to the people of California. The true nature and history of water, flowing through stream, river, delta, bay, and finally ocean...makes us clearly aware that water really belongs to all the people "down-stream" from any point and water-use on the earth.

While water agencies, farmers, and others may have some rights granted to use "the peoples water" in manners that are beneficial and approved, it is the State (the people) that must determine which beneficial uses have priority and approval, and to stipulate how this precious resource is to be managed and protected. Additionally, "todays" environment mandates the State to provide regulations and assurances to deal with changing needs, conditions, and especially climate.

It is the responsibility of the California State Water Resources Control Board to represent all people of the state in these matters.

To this end, "the true public interest", I strongly encourage the California State Water Resources Control Board to represent all the people of the state and go forward with approval and robust enforcement of the currently drafted "Bay Delta Water Quality Control Plan".

The drafted plan is entirely fair and equitable to all "upstream and downstream humans", stakeholders, and businesses. I believestrongly that at least half of the natural flow from the Stanislaus, Tuolumne,

Merced and lower San Joaquin Rivers should make it to the Bay-Delta, and the ocean. However, the draft plan to share and allocate water in a conditional and proportional manner seems very fair and achievable...but to be successful will require a robust enforcement regime. Additionally, the increased water flow must not be diverted to any other locations, or purposes (i.e. Southern California). The increased flow must be allowed to follow the natural paths completely to the ocean!

The plan also represents an immense improvement to the possibilities of protecting and reviving the populations of wildlife that are continuing to dwindle on a path to extinction (local and regional "extinctions" are already a sad reality). This is because some groups (usually with strong profit motives that are never

satiated) have been given "greater right" to state water. Thus, the common person and wildlife (as a whole) are left to suffer the terrible consequences. The people of this state want the waterways and wildlife of this state to be vibrant, healthy, and diverse...allowing waterways and wildlife to thrive and be accessible for today and the future!


