## Pat's Fly Box - Bird's Nest

This month's fly addition is the Bird's Nest. To me it's a must-have in my trout nymph fly box. It is a great caddis pupae imitation. I use it as the point fly, first fly, then I add a dropper fly, a smaller nymph. Or I use it as the dropper fly to a larger fly. Or just by itself. Either way it is a killer fly.

I like to tie it with Lemon Wood Duck flank feathers because of the warm color tone they offer, and they are just a great looking feather. I'm also giving you an early Christmas gift with the tying instructions. flyfishingthesierra.com.

This is a great site for tying instructions, descriptions of flies, and the flies' histories. Hope you add some to your box this winter.

#### 5 Reasons to Rethink the Future of Dams

The United States must grapple with a legacy of 90,000 dams, many unsafe or unwanted.

The tide has shifted on dams. Once a monument to our engineering prowess, there's now widespread acknowledgment that dam-building comes with a long list of harms. Some of those can be reversed, as shown by the 1,200 dam removals in the past 20 years.

But the future of our existing dams, including 2,500 hydroelectric facilities, is a complicated issue in the age of climate change. Dams have altered river flows, changed aquatic habitat, decimated fish populations, and curtailed cultural and treaty resources for tribes. But does the low-carbon power dams produce have a role in our energy transition? *More* ...

## Tester introduces bill to protect Montana rivers as wild and scenic

GALLATIN GATEWAY — The Gallatin River snaked behind Montana Democratic U.S. Sen. Jon Tester Tuesday afternoon as he introduced a bill to permanently protect hundreds of miles of rivers and streams across southwestern Montana.

Tester and conservation advocates presented the Montana Headwaters Legacy Act in front of the Montana TroutChasers Lodge and Fly Fishing Outfitter here. The bill would designate 336 miles of rivers and streams in the Lewis and Clark and Custer Gallatin National Forests as wild and scenic.

"This place has been discovered. It's going to continue to have more and more people," Tester said. "There's going to continue to be more pressure put on air and water every day, and now we're really past the time to do something about it." *More ...* 

## California Slammed Over 'Blank Check' for Delta Tunnel Project

SACRAMENTO, Calif. (CN) — Lobbing another hurdle at California's \$16 billion plan to tunnel underneath the West Coast's largest estuary, environmentalists on Thursday sued to freeze public funding for the megaproject championed by Governor Gavin Newsom.

Led by Sierra Club and the Center for Biological Diversity, a familiar coalition of critics of the so-called delta tunnel claim the cash-strapped state is pursuing a "blank check" for a project that isn't fully cooked.

"It's outrageous that California officials would commit funds for this massively harmful water tunnel without public engagement or environmental review," said John Buse, the center's senior counsel in a statement. "This boondoggle will destroy the delta ecosystem in a desperate attempt to continue unsustainable water use in Central and Southern California." *More ...*

TWO EXPERIENCES IN TWO DAYS LEFT ME WITH TWO VERY DIFFERENT FEELINGS.

I spent a couple of days fishing in North Carolina a couple of weeks ago. A dear friend came in from Colorado and gave me the chance to share some of our eastern rivers. We had two close encounters with other anglers which proved to be lessons in stream etiquette. One a great example of how to share the water, the other not so much.

Stream etiquette is often complained about but seldom taught. What's expected on the river changes from place to place but there are some simple ideas of respect and tolerance that are universal. If you're not sure what's cool and what's not, I hope these two examples are helpful. *More* ...

## The Unwritten Rules of Fly Fishing Etiquette

Fly fishing is often a solitary sport, and many anglers like it that way. The experience of being alone on a pristine river with just a gentle breeze and the swish of the line playing out, not to mention the glory of reeling in a big one, is an almost religious endeavor for some outdoor lovers. However, there are bound to be the encounters that are memorable for the wrong reasons —and not just because the big one that got away. Instead, it's the fellow fishermen (and women) who sometimes are to blame for a less-than-enjoyable encounter on the water.

### <u>Lahontan — A Trout Unlimited Science Story</u>

Twelve-thousand years ago, there was a lake - Lake Lahontan - that covered more than 8,500 square miles of the Great Basin. Most of the rivers and lakes there today were at some point tributaries to this giant lake, or wholly covered by it. What does that mean for a species that's been in the Great Basin for more than 10 million years in one form or another? It tells us that these fish were once widespread across the landscape with no barriers to movement, so they were likely well distributed without much genetic difference. Learn more by watching our film.

### Wild Trout - A Montana Fish Story - Trout Unlimited

In the 1970's, young Montana biologist Dick Vincent discovered that stocking hatchery-reared trout on top of wild trout populations in the Madison River actually suppressed trout fishing. Based on his research, the state of Montana prohibited stocking streams occupied by wild trout populations turning fisheries managers' attention to restoring habitat quality after decades of pollution, damming, and drying up streams. The shift in focus to quality stream habitat changed the trajectory of Montana's legendary trout fisheries from a steady decline to world class. Since Montana's wild trout policy took hold, angler conservationists with Trout Unlimited and its partners have unleashed four decades of restoring streams and the quantity and quality of the cold, clean waters trout and anglers depend upon. Wild Trout: A Montana Fish Story chronicles Montana's conversion to wild trout fisheries and the profound changes still evident in our beloved trout fisheries.

## How To Spot Trout with Amelia Jensen | Orvis Podcast

Amelia Jensen and her husband David, are fanatical river anglers for trout. They travel throughout New Zealand and western Canada/America each year in pursuit of trout on dry flies. In this fascinating podcast, Amelia is interviewed by Tom Rosenbauer about special techniques for spotting trout...before you spook them. It's often not easy to see a trout near structure and Amelia provides critical information on how to spot them before you cast.

## **Steelhead - Spey fishing Oregon**

This October myself and two friends went to USA and Oregon state to fish for Steelhead for the first time ever. Since 2018 was a difficult season for trout and salmon in Scandinavia we did not want to get our hopes up to much. With that said we where not surprised when we heard that it had been the lowest run of Steelhead in 40 years when we arrived. Either way we had a blast and we all got what we came for, our first wild Steelheads, and we will be back next year!





## Northern California Council, FFI December 2020 Report


#### **Huge Win on the Klamath - Dams are Coming out**



It is with great pride and happiness that I can say that the fight to get 4 dams off the Klamath River in Northern California is nearing the finish line. NCCFFI and interested parties began negotiations for dam removal starting in 2003 to push for removal under the legal requirement to re-license the dams through the Federal Energy Regulatory Commission (FERC). A new 50 year license was being requested by Pacific Power (PacifiCorp) to continue operation. At issue was bringing the dams up to current day environmental standards, which meant fish passage by

anadromous species like salmon & steelhead. The question was: Is it better for PacifiCorp to remove the dams, or upgrade them to allow fish passage. We spent the next 7 years developing arguments to show that removal was financially and ecologically better for everyone.

Two agreements were signed in 2010 to remove the dams and to upgrade the watershed in the upper basin around Klamath Falls to allow fish passage and keep the agricultural community whole with adequate water. For more than 4 years Congress did not act to support the Basin upgrade, and that agreement terminated at the end of 2014. However, a new deal was struck in 2015 to continue the process for dam removal. We have been working on that ever since, including creating a totally independent company, the Klamath River Renewal Corporation (KRRC), to manage all issues related to removal & restoration. They have been securing permits, hiring contractors, working with FERC to meet federal requirements, working with the states on water quality certifications, and meeting with communities to answer questions and



handle concerns. A major partnership has been with the Karuk and Yurok Tribes who live on the river, and meeting their needs in the recovery process.

In 2019 a license transfer request was made with FERC to move the license to operate over to KRRC from PacifiCorp. This past summer 2020 FERC allowed the license to be transferred to KRRC, but held PacifiCorp on the license, making them liable for any risks during removal, as well as any financial overrun costs that might happen. This caused a near termination of the agreement for removal, but we all met and agreed that we'd find a solution, and not terminate the agreement. For the past 3 months negotiations between the 2 states, Tribes, Pacific Power and KRRC have resulted in a Memorandum of Agreement on risk and cost overrun, allowing Pacific Power to be confident they can proceed to decommissioning.

On November 16, 2020 the 2 Governors, Pacific Power leaders, Tribal leaders and KRRC held an announcement Zoom event to share the agreement.

What this means is that all the major barriers to removal are now gone. The final action that FERC must do is allow the license to be surrendered to KRRC, which was formally requested on November 16, 2020. The states of California & Oregon and Pacific Power each added \$15 million to the funding account, to ensure FERC would be confident there is adequate funds available to complete the removal. Permitting and regulatory evaluation will start immediately, and preconstruction work begins in summer 2022, and removal begins January 2023. All 4 dams will be removed simultaneously. On the KRRC website you can have access to all documents showing the process and timing. We are ready to go, and once license surrender is done, the door is fully open to establish a free flowing Klamath in late 2023.

This is the largest river restoration in U.S. history. NCCFFI has been engaged in this effort for nearly 18 years now, and the finish line is in view!

Your NCCFFI is working for you, our members and clubs, on important issues to all who fly fish and care about healthy & vibrant rivers and fish.

This will be a win for our State, Tribes, Fly Fishers and Future Generations
