... Hetch Hetchy Letter

Our club has been asked, along with other FF clubs, to add our signature to a letter to Superintendent Cicely Muldoon, Yosemite National Park, requesting modifications to restrictions re: fishing at Hetch Hetchy. Current regulations require fishers to stay above the high water mark making it realistically impossible to fish. The letter was initiated by Yosemite Outfitters and forwarded to us by Jim Correa of Trout Unlimited and Merced Fly Fishers. Due to the request for a response prior to May 1st, the board discussed and agreed that it is a reasonable request and board member Paul Wallace will sign on behalf of the club. Re: Fishing in Hetch Hetchy Reservoir

Dear Superintendent Muldoon:


Our organizations support fishing in Hetch Hetchy Reservoir. We ask the National Park Service to modify its regulations prohibiting access below the high water mark of Hetch Hetchy Reservoir so fishing is possible.

A sign posted in the parking lot at Hetch Hetchy indicates that fishing is indeed allowed from the bank of the reservoir. The prohibition of access below the reservoir's high water mark, however, as included in the Superintendent's Compendium, in the National Park Service brochure distributed at the Hetch Hetchy entrance, and on the webpage for fishing in Yosemite National Park, effectively precludes fishing.

It's simply not possible to fish in the reservoir if you can't get near the water. Like all water supply reservoirs, the water level at Hetch Hetchy Reservoir fluctuates seasonally and is rarely close to its

high water mark. For example, in calendar year 2023 the water level was within 5 feet of the high water mark for only 60 days in the summer (see Figure 1).

The brochure and Compendium state that prohibition's purpose is to maintain a clean source of drinking water. The Raker Act, however, which authorized the construction of Hetch Hetchy

Reservoir, placed only specific limitations, i.e. no "human excrement, garbage, or other refuse" (shall be placed in the reservoir) and "No person shall bathe, wash clothes or cooking utensils, or water stock in, ruin any way pollute, the water". Further, the Raker Act expressly forbids the National Park Service from granting any additional rules or restrictions to protect water quality beyond those enumerated.

Further, Congress enacted the Raker Act with the full expectation that fishing would be not only permitted but encouraged. Congressmen, including Scott Ferris, Chairman of the Committee on Public Lands when the legislation was considered, enthusiastically embraced fishing in the reservoir.

It is not clear when this de facto ban on fishing was implemented. Until recent NPS website updates, it appeared that year round access was given to fish all of Yosemite's lakes as well as Hetch Hetchy Reservoir.

A storied written history exists of fishing Hetch Hetchy. Numerous visitors, NPS employees, and others have enjoyed the fishery. Hetch Hetchy Reservoir has some of Yosemite's largest trophy trout and provides outstanding value as a fishery. It is unreasonable to restrict recreation for responsible users who wish to respect the landscape and the National Park Service.

We ask the National Park Service to rescind the current prohibition on access below the high water mark of Hetch Hetchy Reservoir so park visitors can fish.
